

BOARD APPLICATION AND POSITION DESCRIPTION

Overview

The LaTech African-American Alumni Association (LaTech AAA) governs the overall execution of the organization's mission. Principally, the Board manages organizational finances and sets long term priorities for programs and provides support to the organization's committees. Overall, the members of the Board contribute the educational, management, legal, and financial skills needed to ensure long term organizational stability and ensure year-to-year educational excellence for LaTech AAA's mission.

The Board of Directors has 10- 25 voting members. Terms are for 2 years. The following positions require that an application is submitted:

- The elected officers (4)
- Immediate past president (1)
- The Directors-at-large (5-10) (Aim for each decade represented)
- Standing committee chairpersons (5-10) (Must be recommended by the President)

Board Member responsibilities include attendance regular board meetings (average 12 per year), as well as teleconference meetings and active electronic conversations as part of Board committees. In some years the Board has held additional meetings. Board members also hold a fiduciary responsibility for management of organizational capital and ensuring appropriate filings with federal, state, and local authorities consistent with the organization's status as a 501(c)(3) nonprofit organization. The attendance policy allows for removal if three consecutive meetings are missed without notice.

Declaration of Candidacy

Board positions require a time and energy commitment that should not be underestimated. Candidates are urged to consider personal priorities for the next year as well as the ways to contribute to the development of the organization.
